From your Wardens....

For this note, we have an update on the finances for 2023, and an update on the Restorative Process we've been engaged in.

Finances

You'll remember from the Vestry meeting in February, we approved a budget with a really big deficit. Here's a short summary of where we are as of June 25, 2023:

Revenue, 2023 budget	\$82,659
Donations, % of budget to date	48%
Percentage of year (to June 25)	48%
Projected revenue at end of 2023	\$80,769
Routine expenses by end May	\$69,436
Projected expenses to end 2023	\$181,710
Expenses, % of budget (end May)	38%
Percentage of year (to end May)	41%

We're pretty much exactly on budget in terms of revenue, and we have expenses under control in terms of what was budgeted. While that might seem good on the surface, all it really means is we did a reasonably great job of projecting income and expenses. In reality we are spending a lot more money than we have coming in, and that's just on the routine, regular expenses like utilities, wages, etc. This analysis does not take things like repairs into account.

Here's one interpretation of what these numbers mean:

Bequest interest	\$22,068
Projected shortfall	\$100,941

If this continues, we'll use up our investment in a few years. We recognise that we all have expenses of our own, and we know it's not realistic to expect everyone to donate that much more. We also understand how difficult many of us find it to invite people to join us (and we certainly don't want to invite people just so they'll help with the expenses). However, we do implore that we all very prayerfully ponder how this challenge could be overcome. We know that if we're doing what God wants us to be doing, He will see to our needs. However, we also remember the parable of the talents, and to paraphrase from Peter's sermon last Sunday: "Without God, we cannot; without us, God will not"...

Restorative Process

As you know, we were to have held a facilitated planning day on Saturday, June 17, as something of a culmination of the various discussions we have had over the past year. The reason that day was not held is that Bill Bickle's wife contracted covid the day before, which forced us to cancel and plan to have the facilitated planning day later. We now hope to have this day on Saturday, September 9, so please reserve that date for the planning day. This is meant to be an open-to-all exercise; the more of us participating, the better the results we'll achieve.

The various Circles we have had over the past year or so yielded many items of value. Bill and Heidi, our facilitators, have distilled all of these into the four main categories listed in the first column of the following table. It outlines the outcomes that we hoped for on June 17, and now hope for on September 9, plus what we hope could possibly be done before that, if people are willing.

Lakefield Community Food Bank

The Lakefield Community Food Bank is much more than just a place where people in need are handed some food. It is a special place where both volunteers and recipients give and receive with generosity and gratitude. It is a true example of the "Kingdom of God" at work.

Our food bank finally has a new 54" wide, 47 cu./ft. commercial refrigerator. Many thanks to Jason Hamilton for persevering to find this fridge and arranging to have it delivered and set up in the lower hall. Reverend Peter gave a prayer of blessing over the new fridge. This new fridge is a true blessing, allowing us to keep lots of food fresh to share it with our recipients!

Our statistics show the Food Bank is serving many people. So far in 2023, we have provided food to 192 different households. These households are made up of 329 adults and 152 children. On average, 79 households visited our Food Bank each week.

Although the need for support remains high, individuals, groups, churches, and businesses in the Lakefield community and beyond continue to be extremely generous. We are amazed and blessed by the wonderful support. Because of this generosity we can offer a wonderful selection of items to our recipients.

Lakefield College School -Northcote Campus has once again commenced bringing totes of fresh food weekly. Programs at Lakefield College School provide students with opportunities to learn about eco-farming and food production through hands-on experiences on the school farm. We are happy to receive this year's crops to offer to our recipients. Thank you!

Don Smith, the coordinator of Lakefield Community Garden, has established this garden to serve the community. Local residents are encouraged to plant plots. Don and food bank



stewards have planted several plots for our Food Bank. Volunteers plant, weed, harvest and transport fresh produce to the Food Bank. Already things are growing beautifully at this

Lakefield Community Garden. Thanks to all the wonderful gardeners & volunteers! Our Food Bank recipients will certainly enjoy the fruits of your labour!

The Consecration Certificate 1869 of what is now known as St. John the Baptist Anglican Church, Lakefield.

I believe this to be "almost" the exact transcription of the original document, as you can see it is difficult to read the script. Further to this Shirley Twist sent me this and some other historical documents about St. John's that Joe Latour came upon when researching Christ Church. I plan to print out some of these documents and do a "summer" display on the bulletin board between the washrooms. Keep an eye out for these historical memories of the very early beginnings and some a bit later of St. John's. Margaret H.

In the name of God. Amen.

Whereas it hath been represented to us Alexander Neil, by Divine permission Lord Bishop of Toronto, by petition under the hands of Vincent Clementi, Incumbent of the church of St. John Baptist, North Douro and in our Diocese,

and of Robert Casement and Robert A. Strickland churchwardens, and given others, Parishioners thereof, setting forth, among other things, that a building has been erected in North Douro for a church in connection with the United Church of England and Ireland, on a parcel of land being Lot seventeen and part of Lot fourteen in the Village of Lakefield, North Douro as a site for the erection of a church in connection with the United Church of England and Ireland, to be called the Church of St. John Baptist and that the said building is furnished with all things necessary for the performance of Divine Service, according to the uses and customs of said United Church, and the provisions of the Book of Common Prayer, and praying that we would be pleased by our authority, ordinary and Episcopal, to set apart, separate and consecrate the said building to the sacred purposes for which it was designed, under the name and title of the Church of St. John Baptist in order that it may forever be secured for these ends to said Parishioners and their Ancestors, uses whatever, and do, as far as in us lies, and by law we can, assign the said sacrifice as a church, under the name and title of the Church of St. John Baptist for the use and benefit of the Parishioners thereof; and we do dedicate and consecrate the same sacred purposes for which it was designed, and do, publicly and openly, pronounce, decree, and declare the same to be assigned, separated, dedicated and consecrated forever; and that the same ought so to remain by this my definite sentence and final decree, which we read and promulge by these present.

Given under our hand this twenty sixth day of May in the year of our Lord one thousand and eight hundred and sixty nine and of our consecration the third year.
